In order for parents and volunteers to transport students to and from events away from the immediate campus, PPCS's liability insurance requires drivers to declare that they have insurance coverage for the vehicles they will be driving. Please fill out the form below and sign on the appropriate line.

I understand the liability responsibility for Palouse Prairie Charter School of Moscow, Idaho, begins at \$250,000 combined single limit (Or split limits of \$250,000/\$500,000/\$100.000).

My liability insurance is considered the primary coverage. In order to drive PPSEL students, I carry \$250,000 coverage on my vehicle. I possess a valid driver's license and am at least 25 years of age.

Cell Phone Usage

It is an expectation that Palouse Prairie School parents will not use cell phones to talk or text while driving students to and from school sponsored events. This includes fieldwork, Adventure trips, and excursions. We expect parents to take extra care when driving students. If you have an emergency and must use the phone, please pull your vehicle over to a safe place to make your call. As always, continue to enforce our expectation for good behavior in the car—behavior should never distract a driver. Thank you for your cooperation with this very important issue.

Use of Seatbelts & Child Safety Restraints

We conform with Idaho's Child Restraint Law, Idaho Code 49-672, which states that all children 6 years of age and under will be properly restrained in an appropriate child safety restraint. ALL PPSEL kindergarten and first graders will use a booster seat when traveling for school fieldwork. All boosters must be secured with a lap and shoulder belt.

All students over the age of 6 shall also wear a seatbelt in vehicles. We encourage the use of both a lap and shoulder belt for these students as well.

No child under the age of 13 shall ride in the front seat of a car.

Palouse Prairie Driver License & Insurance Verification:

All PPSEL parents driving for fieldwork, Community-led Learning or any other school off-site trips, MUST submit the following:

- 1. A valid copy of your current driver license
- 2. A copy of your proof of insurance (the one you carry in your glove box).
- 3. A signed insurance waiver form
- 4. A signed acknowledgement of our volunteer and transportation policies

I have read and will abide by Palouse Prairie's Volunteer and Transportation Policies. If I am driving Palouse Prairie Students on a school-approved trip, a copy of my current driver's license and proof of insurance has been made available to be kept on file at Palouse Prairie School.
