Professional Services Contract

This contract is between the Palouse Prairie Charter School (hereinafter "school") in Moscow, Idaho 83843 and the regents of the University of Idaho (hereinafter "contractor"), Moscow, Idaho for school psychological evaluation services for the purpose required by law. Said contractor represents that they are duly qualified and agrees to perform all services described in the contract to the satisfaction of the school on an "at will" basis.

1. Term of Contract

Effective Date: August 15, 2018

Expiration Date: August 14, 2019, or until all obligations have been satisfactorily fulfilled, whichever occurs first.

2. Contractor's Duties

The contractor, who is not a district employee, will: provide psychological evaluation services, develop eligibility reports for student Individual Educational Program (IEP) Teams, as directed by the school's Executive Director or their designee; make recommendations for accommodations and interventions as appropriate for Individual Education Programs.

3. Time

The contractor will complete all contracted evaluations within the allowed time limits specified in the Idaho Special Education Guidelines. Failure to meet specified deadlines may result in termination of the contract at the sole discretion of the school's Executive Director.

4. Consideration and Payment

- a. **Compensation.** The contractor will be paid at a rate of \$80.00 per hour.
- b. **Payment.** Payment for services rendered will be made within fifteen (15) business days receipt of a valid and approved invoice.

5. Conditions of Payment

All services provided by the Contractor under this contract must be performed to the School's satisfaction, as determined at the sole discretion of the Palouse Prairie Charter School Director and in accordance with all applicable federal, state, and local laws, ordinances, rules, and regulations. The Contractor will not receive payment for work performed in violation of federal, state, or local law.
