

**MOSCOW SCHOOL DISTRICT 281  
TRANSPORTATION SERVICES AGREEMENT  
FY 2020-2021**

WHEREAS, Moscow School District 281 is a public school district organization and existing under the laws of the State of Idaho;

WHEREAS, Palouse Prairie Charter School, has students enrolled that necessitate transportation to and from their place of residence;

WHEREAS, Moscow School District 281 owns and operates a fleet of buses over established routes and stops as approved by its Board of Trustees and at this time has space available on such buses for accommodating and transporting those students of Palouse Prairie Charter School that necessitate transportation;

WHEREAS, it is recognized by the parties hereto that in the event the buses of Moscow School District 281 are to transport students of Palouse Prairie Charter School that Moscow School District 281 needs to be reimbursed for the incurred costs thereof;

WHEREAS, in view of the foregoing recitation these two school entities desire to enter into an agreement for the transportation of the students of Palouse Prairie Charter School:

NOW, THEREFORE, those parties agree, one with the other, as follows:

1. Commencing September 14, 2020 and ending June 09, 2021, Moscow School District 281 agrees to transport on its buses those students of Palouse Prairie Charter School that would otherwise qualify for transportation to a public school in accordance with the laws, rules, regulations and policies of the Idaho State Board of Education and Moscow School District 281, subject, however, that in any event, this agreement is conditioned on space being available on such respective buses.
2. The pickup of a student from his/her residence or the vicinity thereof shall be in accordance with the designated route and route stops established and approved by Moscow School District 281 with the delivery of student to Palouse Prairie Charter School. All scheduling as to times and dates will be established and approved by Moscow School District 281.
3. Palouse Prairie Charter School agrees to properly supervise the loading and unloading of its students by an adult or adults at Palouse Prairie Charter School premises and at any shuttle collection location.
4. The students of Palouse Prairie Charter School riding the buses of Moscow School District 281 shall be subject to all laws, policies, rules and regulations applying to other students being transported on such buses.
5. By September 10, 2020 Palouse Prairie Charter School shall certify to Moscow School District 281 a list of its students that require transportation for the 2020-21 school year and the number of transportation days required. This list shall include primary and emergency contact information for each student.
6. The Moscow School District 281 will invoice the Palouse Prairie Charter School on a monthly basis for transportation costs based on the September 10th list of students requiring transportation. It will be the responsibility of the Palouse Prairie Charter School to notify Moscow School District Transportation Office by the 15<sup>th</sup> of each month of changes in the number of students requiring transportation caused by students' enrollment. Daily attendance will not be a factor in calculating transportation costs.

7. Requests for student transportation beyond to and from school transporting will be limited to destinations of not more than one hundred (100) miles from the Moscow city limits. Requests for other than to and from school transportation must fall within the Moscow School District's definition of field trips and will be billed to the Palouse Prairie Charter School as field trips. Requests for such trips will be submitted to the Moscow School District Transportation Department on approved request forms and within the timelines set by District policy. Field trip limitations placed on Moscow School District schools shall apply to Palouse Prairie Charter School.

8. Transportation costs for Palouse Prairie Charter School students shall be calculated as follows:

To/From School Transportation – The percentage of non-reimbursable cost as determined by the State Department of Education (SDE) under formula guidelines amounts to \$1.93 per rider per day.

Field Trips – For Reimbursable Field trips, busing will be billed at \$1.60 per mile or \$15.12 per hour, whichever is greater. Nonreimbursable Field trips are \$5.93 per mile or \$56.00 per hour, whichever is greater.

9. Busing is contingent upon approval of the agreement by all parties. Either party to this agreement may terminate the same by giving the other party at least 90 days written notice of intention to terminate, designating the effective date of termination.

All parties further agree that should information become available altering in any manner the fees upon which this agreement is based, corrective action would be taken to reflect the revised costs.

10. The persons signing this agreement on behalf of Palouse Prairie Charter School represent that it has been approved by the governing body of said school, namely the Palouse Prairie Charter School; that they are authorized to sign on behalf of said school; and that said school will be financially responsible for all payments that may become due under this agreement.

The persons signing this agreement on behalf of Palouse Prairie Charter School hereby guarantee payment of all payments that may become due under this agreement on behalf of Palouse Prairie Charter School.
